## **ECMA Annual Meeting 2024**

## General Terms and Conditions of the Event Registration and Cancellation Policy

The present terms and conditions apply to the table top exhibition organized in the framework of the ECMA Convention on 18 April 2024 as well as to sponsorship for the ECMA Annual Meeting on 17 - 19 April 2024. The Table top exhibition will take place at the Melia Sarria Hotel in Barcelona, Spain.

### 1° Description of Table-Top Exhibition

Alongside the ECMA Convention, in the area where coffee breaks will be taking place and just outside the meeting rooms for breakout sessions, a table-top exhibition will be organized.

ECMA will be providing exhibitors with exhibition space and one table & two chairs. The furniture provided will be the same for all stands.

On the space allocated to them, exhibitors are free to display banner stands, brochures, small objects or to display presentations on a computer. It is strictly forbidden to display exhibits outside the allocated space, as well as to display large or heavy exhibits. The hotel will provide detailed shipping instructions.

The set-up times of the table-top exhibition will be announced a few weeks in advance. The sponsor/exhibitor has to follow the instructions given by the hotel.

### 2° Exhibition space allocation

Space will be allocated on a first come – first served basis. No space will be allocated as long as payment is not received in full

#### <u>3° Cancellation Policy - Cancellation by the exhibitor / sponsor</u>

Exhibitors and sponsors can cancel their participation until 15 February 2024 . Until that date, payments already received will be refunded (limited to the amount paid). However, a fee of 150 EUR will be charged to cover administrative and banking costs. Refunds will be handled after the event.

In case of cancellation after 15 February 2024 or in case of no-show, fees paid will not be refunded.

#### 5° Cancellation Policy - Cancellation by the organiser

If ECMA cancels the event for any reason other than force majeure, fees will be refunded to the exhibitors / sponsors. However, refunds are limited to the amount paid by exhibitors / sponsors. ECMA is not liable for any other loss or expenses incurred by exhibitors / sponsors as a consequence of the cancellation.

In the event that the ECMA Convention 2024 would be cancelled, postponed or relocated on account of fire, flood, riot, earthquake, civil commotion, decisions taken by the national and/or local authorities, weather conditions, strike, lock-out, labour disturbances, explosions, sabotage, accident, terrorism, war, acts of God or any other causes or casualties beyond the control of ECMA, no refund shall be made. Exhibitors / sponsors waive all claims for damage in this case.
